Research and innovation can help to develop community economies to be diverse and sustainable, such as developing a green community economy, cultural-based community economic development. Community economy development through research and innovation requires cooperation from all sectors, including the government, private sector, and civil society. The important driving directions include developing research and innovation systems for the community.
